MINUTES OF THE REGULAR MONTHLY MEETING OF THE BOARD OF DIRECTORS FOR MARCH 17, 2016

CALL TO ORDER: By Chairman Suzie Coe at 7:03 PM.

DIRECTORS PRESENT: Chairman Suzie Coe, Vice-Chairman John Dell'Orto,

Secretary/Treasurer E. Cavalli Jr., Director Ted Shannon.

DIRECTOR ABSENT: Director Del Albright.

OTHERS PRESENT: Fire Chief David Spitzer, Battalion Chief Mike Dell'Orto and others.

PUBLIC COMMENT: Mike Moran reported that flyers had been posted for the Firefighters Ball on April 2nd; Mr. Moran also noted the Veterans Memorial District's annual crab feed would take place on April the 9th.

MINUTES OF PREVIOUS MEETINGS: Minutes of the previous regular meeting of February 18, 2016 and the special meeting of February 23 were approved after a motion by Director Cavalli, second by Director Dell'Orto and a 4-0-1 vote.

CORRESPONDENCE:

- 1) Received notice from the <u>Calveras Public Power Association</u> that rates would rise by 2 cents per Kilowatt Hour in July. Also, CPPA is looking for board nominees.
- 2) Directors Dell'Orto and Cavalli must each sign a document affirming they wish to remain on the MHFPD Board of Directors.
- 3) Director Cavalli made a motion, seconded by Director Dell'Orto to pass Resolution number 16-03-1 advising that the MHFPD Board approved moving the county election date from June to November to coincide with the general election. Motion passed 4-0-1.
- 4) Received an application form for the MHFPD to join the National Fire Protection Association. No interest, therefore no action.
- 5) Received a letter from Fechter & Co. proposing to perform our annual audit.
- 6) Possible website issue. No problem perceived by majority of board, no action.
- 7) Director Coe has been in contact with Peter Maurer, director of the Calaveras County Planning Department; he suggested MHFPD request that the Calaveras County Board of Supervisors waive all fees for the Paloma Fire Station. Director Coe has written the letter.

- 2) Continue to hire Debbie for assisting Fire Chief with Calaveras County Auditor's paperwork. Director Cavalli made a motion to do so through this fiscal year, seconded by Director Shannon, passed 4-0-1.
